




Assembly Steps 1-3


Step 1: Remove 1 Right Back Post (B) and 1 Left Back Post (C) from the bottom of the Chair Base (A).

Step 2: Untie the AC Power Code (E) and remove.





Step 3: Plug the 3 Chair Back (D) into the Chair Base (A) correctly and buckle the 1 Right Back Post (B) and 1 Left Back Post (C) on the the Chair Base (A) one by one.





Step 4: Make sure the AC Power Code (E) is wired up correctly so that the devices can charge via USB port.





Care & Use Instructions

- Water Based Cleaner "W": Spot clean cloth using only a water-based cleaning agent such a mild detergent or non-solvent upholstery shampoo product. Apply with a soft cloth in a circular motion. Vacuum when dry.
- It is recommended to not place furniture in direct sunlight and keep furniture 2 ft. / 60 cm from heat sources to avoid fading.
